

Resolution No. 2013-5
**A Resolution to initiate process for altering White River Road, Town of Delta,
Bayfield County Wisconsin**

The Town Board of the Town of Delta, Bayfield County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

The process under Chapter 82, Wis. stats., to alter a highway in the town described as follows is here by initiated: White River Road located in the SE ¼ of the SE ¼ of the SE ¼ , Section 23, T.46N., R.7W., Town of Delta, Bayfield County, Wisconsin.

BE IT RESOLVED THAT:

1. A public hearing to discuss proposed Resolution No. 2013-6, (a copy of which is included in this document, below this Notice) to alter a highway in the town, shall be held on July 16, 2013, at the Town of Delta, Town Hall, 15990 County Hwy H, Mason, Wisconsin, beginning at 7:00 p.m. This hearing is scheduled pursuant to Wis. Stat. § 82.10 (3).

2. That the Clerk of the Town of Delta be authorized and directed to personally serve the Notice of this public hearing, upon all of the owners of land abutting the highway to be altered and any other parties required to be served under Wis. Stat. § 82.10(4).

3. That the Clerk for the Town of Delta is further authorized and directed to publish a Class III Notice of the public hearing referenced above, pursuant to Wis. Stat. § 985.

4. That the clerk shall file on behalf of the town board a lis pendens within 10 days of the introduction of the resolution, pursuant to Wis. Stat. § 82.10 (5).

Proposed Resolution No. 2013-6

A Resolution Proposing To Alter White River Road, Town of Delta, Bayfield
County Wisconsin

WHEREAS, the Town of Delta has proceeded to enable public access to public lands under the action described in the Town of Delta Resolution 2013-4; and

WHEREAS, the existing maintained highway known as White River Road on the Town of Delta owned Right-of-Way (ROW) is approximately 275 feet short of the boundary line on S23 and S24 in T46N R07W; and

WHEREAS, the Town of Delta Town Board believes that this alteration of White River Road insures the public interest will be served because the public will have access to the DNR land referenced above; and

NOW THEREFORE, BE IT RESOLVED, that the Town of Delta Town Board, Bayfield County, Wisconsin, adopts the following resolution:

1. Extend White River Road approximately 275 feet eastward on the existing 100 ft ROW in the SE, SE, S23-T46N-R07W to the boundary line of SW, SW, S24-T46N-R07W.(04-016-2-46-07-23-4-04-000-20000)
2. A highway order shall be recorded with the register of deeds of Bayfield County and shall be filed with the town clerk.
3. The town clerk shall submit a certified copy of the order to the county highway commissioner.
